CC& R'S CORNER

UNDERSTANDING MONTERRA'S CC&RS

The Covenants, Conditions, and Restrictions (CC&Rs) for the Monterra of Fate Owners Association were officially filed with Rockwall County in April 2023. These governing documents outline the rules and guidelines for all Monterra homeowners, who agree to abide by them as part of the home-buying process.

WHY CC&RS MATTER

The CC&Rs are designed to protect and enhance the quality of life in our community. They help ensure consistent standards for property use, upkeep, and appearance, which benefits both homeowners and the HOA by preserving property values and fostering a cohesive neighborhood environment.

WHAT HAPPENS IF THERE'S A VIOLATION?

If a homeowner is found in violation of the CC&Rs, such as through unapproved changes, improper use, or other non-compliant actions, the HOA follows a fair process. This may include a courtesy notice with a correction deadline, a formal written notice with the opportunity for a hearing, and, if necessary, referral to legal counsel. The goal is always to maintain a respectful and well-kept community for all.

MESSAGE FROM THE HOA

Dear Neighbors,

My name is Lance Megyesi. I was on the Fate City Council when Monterra was first conceived and experienced all the legal battles and changes that transformed into what we have today. We purchased our home in Monterra in February 2024 and moved in during December.

Like you, I have a vested interest in our neighborhood and am committed to ensuring our home values increase. It's important to remember that Monterra is less than two years old, and typically HOAs remain under developer control until 90% of the homes are sold. It is unusual for a developer to start involving residents early, which indicates their interest in homeowners' concerns.

Remember, when we moved into this neighborhood, we all agreed to the Covenants, Conditions, and Restrictions.

We may not like some of the rules and there are many different points of view (just look at the Facebook page) but we need to have a base set to keep the risk to the HOA low. I promise to communicate, and I will always be honest with the information. Every decision will always be in the best interest of the HOA as a whole. I will work to make sure our rules are applied consistently and that there is a process that does not make it seem so arbitrary.

ABOUT LANCE MEGYESI

I moved to Phase 1 of WoodCreek in 2005 from Portland, Oregon, with my wife Paula and daughters. I hold a degree in Computer Science and have a strong background in Finance. In 2012, I ventured into city politics and was elected to the City Council in 2014, serving until May 2025. During my tenure, I held three City Council seats, served as President of the Fate EDC, sat on the P&Z Board, was a member of multiple PID boards, and served on the Fate Public Facilities Corporation and the Rockwall County Open Space Alliance board. These roles provided me with invaluable insights into local government, land development in the City of Fate, and the operations of local boards.
